



## **General Data Protection Regulations – Privacy Notice from Disability North**

The General Data Protection Regulations place a requirement on all organisations that process data to provide a Privacy Notice to every person they hold information about. This might just be your name and address, or it might be detailed case notes, but whatever the situation, we have to give you this Privacy Notice.

### **Data Controller**

Disability North is the Data Controller. That means we are an organisation that has some information about you.

### **How Disability North processes your data**

Disability North complies with its obligations under the GDPR by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data. We use your personal data for the following purposes: -

- In order to offer our support service and maintain case notes.
- To keep you informed of any changes to Direct Payments/Personal Health Budgets, particularly any legal changes around employment.

### **The legal basis for processing your data**

Processing is necessary for the legitimate interests of Disability North. Essentially, we only keep the information we need in order to provide the service and/or support that we are offering you.

### **Sharing your personal data:**

With the following exceptions we do not share your personal data with any other organisations:



- Disability North receives referrals from Newcastle City Council and Newcastle and Gateshead CCG and therefore may have to share information about your situation with the appropriate referring organisation.
- If a safeguarding issues arises, information may have to be shared during the safeguarding process.
- If there is a criminal investigation and we are requested to provide information, we may have to do so.
- If you ask us to set up payroll, insurance, pension or some other service on your behalf, then we will only pass on the details that the organisation needs to set up the service for you.

### **How long do we keep your data:**

Because we provide an ongoing service, we will retain our case notes for as long as you are receiving Direct Payments or a Personal Health Budget. All information relating to you will be deleted a minimum of 6 years after we are made aware that your Direct Payments or Personal Health Budget have ceased.

### **Your rights regarding your personal data:**

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which Disability North holds about you;
- The right to request that Disability North corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for Disability North to retain such data;
- The right to request that Disability North provides you with your personal data and where possible, to transmit that data directly to another organisation, (known as the right to data portability). This right will only apply if you move to another Local Authority area or the Support Service is transferred from Disability North to another organisation.



- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data, (where applicable)
- The right to lodge a complaint with the Information Commissioners Office.

### **Transfer of Data Abroad:**

Disability North do not transmit your data to any other country.

### **Automated Decision Making:**

Disability North do not use your information in any automated decision making process.

### **Further processing:**

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
